Type of harm or abuse, definition	Guidance
Child sexual exploitation (CSE) ...exploitative situations, contexts and relationships where young people receive something (for example food, accommodation, drugs, alcohol, gifts, money or in some cases simply affection) as a result of engaging in sexual activities. Sexual exploitation can take many forms ranging from the seemingly 'consensual' relationship where sex is exchanged for affection or gifts, to serious organised crime by gangs and groups. Bullying including cyberbullying Bullying is behaviour by an individual or group, repeated over time, that intentionally hurts another individual or group either physically or emotionally. Bullying can take many forms (for instance, cyber-bullying via text messages or the internet), and is often motivated by prejudice against particular groups. Many experts say that bullying involves an imbalance of power between the perpetrator and the victim.. The imbalance of power can... be physical, psychological (knowing what upsets someone), derive from an intellectual imbalance, or by having access to the support of a group, or the capacity to socially isolate. <p>Domestic violence</p> <p>The cross-government definition of domestic violence and abuse is:</p> <p>any incident or pattern of incidents of controlling, coercive, threatening behaviour, violence or abuse between those aged 16 or over who are, or have been, intimate partners or family members regardless of gender or sexuality. <p>Fabricated or induced illness</p> <p>There are three main ways of the carer fabricating or inducing illness in a child. These are not mutually exclusive and include:</p> <ul style="list-style-type: none"> • fabrication of signs and symptoms. This may include fabrication of past medical history; • fabrication of signs and symptoms and falsification of hospital charts and records, and specimens of bodily fluids. <p>Faith abuse</p> <p>Relating the guidance below: This plan aims to address certain kinds of child abuse linked to faith or belief. <p>Gangs and youth violence</p> <p>'Street gangs' for whom crime and violence are a core part of their identity, although 'delinquent peer groups' can also lead to increased antisocial behaviour and youth offending. <p>removal of the female external genitalia or other injury to the female genital organs for non-medical reasons.¹ There are four types of FGM, ranging from a symbolic prick to the vagina to the fairly extensive removal and narrowing of the vagina opening. In the UK all forms of FGM are prevalent. FGM is also sometimes known as ‘female genital cutting’ or ‘female circumcision’. However, circumcision is not an appropriate term. <p>Preventing radicalisation</p> <p>Section 1 of the Terrorism Act 2000 defines terrorism as “the use or threat of action ...designed to influence the Government or to intimidate the public or a section of the public ... for the purpose of advancing a political, religious or ideological cause.”</p> <ul style="list-style-type: none"> • Radicalisation is defined in the Prevent Strategy as “the process by which a person comes to support terrorism and forms of extremism leading to terrorism.” • Extremism is defined in the Prevent Strategy as “vocal or active opposition to fundamental British values, including democracy, the rule of law, individual liberty and mutual respect and tolerance of different faiths and beliefs. We also include in our definition of extremism calls for the death of members of our armed forces, whether in this country or overseas.” 	<p>Channel is a programme which focuses on providing support at an early stage to people who are identified as being vulnerable to being drawn into terrorism. <p>Trafficking</p> <p>Article 3 of the <i>Palermo Protocol To Prevent, Suppress And Punish Trafficking In Persons, Especially Women And Children, Supplementing the United Nations Convention Against Transnational Organised Crime to the UN Convention (2000)</i> (ratified by the UK on 6 February 2006) defines trafficking as:</p> <p>a “Trafficking of persons” shall mean the recruitment, transportation, transfer, harbouring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation. <p>crimes relating to gender-based violence (http://www.unwomenuk.org/breast-ironing-must-be-stopped/). The custom uses large stones, a hammer or spatulas that have been heated over scorching coals to compress the breast tissue of girls as young as 9 years old. Those who derive from richer families may opt to use an elastic belt to press the breasts so as to prevent them from growing. The mutilation is a traditional practice from Cameroon designed to make teenage girls look less "womanly" and to deter unwanted male attention, pregnancy and rape. The practice is commonly performed by family members, 58% of the time by the mother (http://www.ohchr.org/Documents/HRBodies/CEDAW/HarmfulPractices/GenderEmpowermentandDevelopment.pdf). <p>Honour based violence</p> <p>"Honour based violence' is a crime or incident which has or may have been committed to protect or defend the honour of the family and/or community."</p> <p>The terms "honour crime" or "honour-based violence" or "izzat" embrace a variety of crimes of violence (mainly but not exclusively against women), including assault, imprisonment and murder where the person is being punished by their family or their community. They are being punished for actually, or allegedly, undermining what the family or community believes to be the correct code of behaviour.
